To recover the badge, during a first registration, you will receive an email to print from [decheteries@univalom.fr](mailto:decheteries@univalom.fr) once the file has been instructed by the service. The email should be presented in person, with your ID card, in one of the UNIVALOM recycling centers where you can make your deposit: Antibes, Bézaudun, Cipières, La Colle-sur-Loup, Le Cannet, Mougins, Mouans-Sartoux, Puget-Théniers, Roquefort-les-Pins, Roquesteron, Valberg, Valbonne et Vallauris.

**It is your responsibility to inform our services in the event of:**

- theft or loss of the access badge in order to cancel it and thus avoid any fraudulent use.
- any change of contact details.

In accordance with the Internal Regulations, the badge is strictly personal and non-transferable.

You remain responsible for it and the use made of it. So, you will have to pay the notices of amounts to be paid sent by the public finances of Antibes. The verification of the ticket as well as any complaint related to your contribution must be made the same day with the agent. Any subsequent complaint will not be admissible.

It is your responsibility to update your file every 2 years on the anniversary date.
